Who we are:

Desert Channels Queensland is a community-based natural resource management (NRM) organisation that delivers projects and provides services across the Queensland section of the Lake Eyre Basin.

For nearly 20 years, we have partnered with landholders and communities to invest in soil, water, pasture and biodiversity across our region. We're a dynamic, award-winning, "roll-up-your-sleeves" team that is experienced in weed management, feral animal control, revitalising springs, property mapping, data capture, sustainable agriculture, threatened species monitoring and improving land condition. As a Longreach-based not-for-profit, we have dozens of projects "on-the-go" that invest in the condition of natural resources across the vast 51 million hectares of our iconic Western Queensland region.

Position Objective:

The NRM Officer will be responsible for delivering NRM (soil, water, land and biodiversity) projects within the Desert Channels region; including field monitoring, coordinating and managing projects, data collection, event delivery, community engagement, and educational and communication activities, and a diverse range of support for program/project staff to meet project deliverables and milestones.

The role partners with community groups and landholders to support the uptake of sustainable land management practices, including land and water management, biodiversity conservation, healthy pastures and soils, and effective climate-smart agriculture and environmental management practices. Project support includes data tracking and acquittals of projects, managing aspects of reporting obligations, project budgets and supporting project logistics.

Key Responsibilities:

The key activities and deliverables for this position are:

1. Coordinate, manage and maintain projects, as well as appropriate data and tracking (and acquittals if required), of all DCQ projects.

2. Increase community awareness and access to knowledge of sustainable grazing, land management and natural resource management (soil, water, pasture, biodiversity) practices.

- 3. Collaborate with the GIS Officer and Field team to ensure monitoring and reporting systems are maintained.
- 4. Develop and deliver community engagement, communication materials and events that relate to projects.
- 5. Support the Senior Project Officer and Operations Manager to develop projects, and / or manage client relationships.
- 6. Manage historical and new projects data.
- 7. Collate project information (in both hardcopy and soft formats) and develop performance reports.
- 8. Attend team meetings and workshops as required.
- 9. All work must be done in accordance with approved workplace health and safety requirements, DCQ policies and procedures.
- 10. Staff are to conduct themselves at all times in accordance with DCQ's Code of Conduct and present a positive image of DCQ in behaviour and demeanour.

- 3. Demonstrated ability to engage with a wide range of stakeholders (landholders, communities, state and local government, industry, build relationships and co-ordinate to meet project outcomes.
